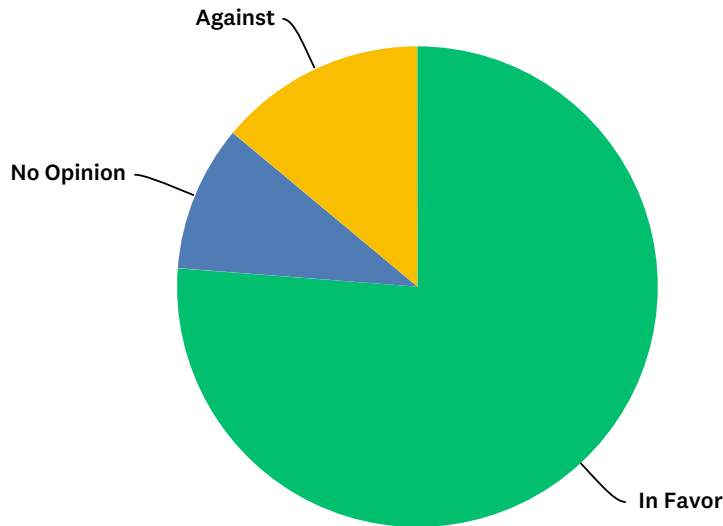


# Q1 No demolition during the period July 1 until the Friday immediately following Labor Day. Do you support this ordinance change?

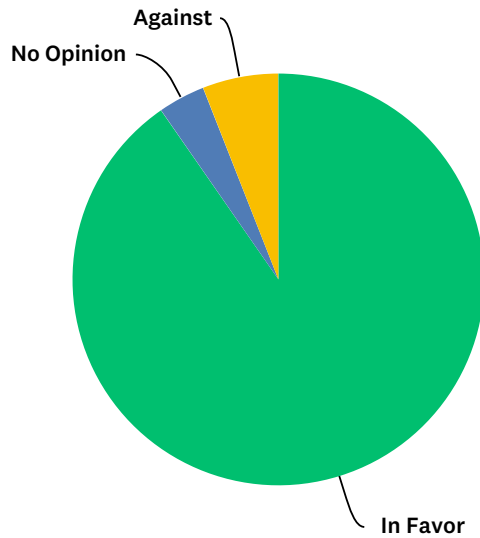

## Q2 No work on any site prior to 8 am or after 6 pm. No heavy equipment prior to 9 am. Do you support this ordinance change?

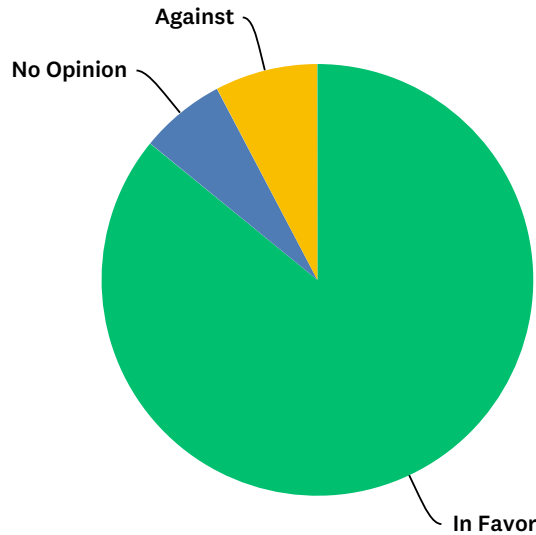

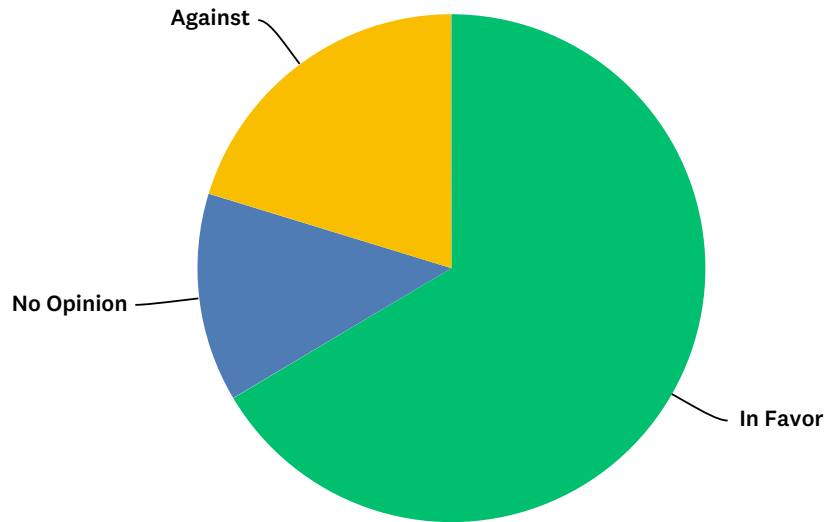

### Q4 Only interior work is permitted on Saturdays, from 9:00 am to 5:00 pm from July 1 until the Friday after Labor Day.

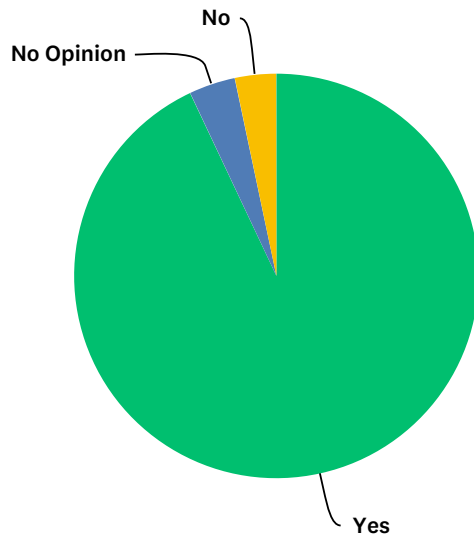

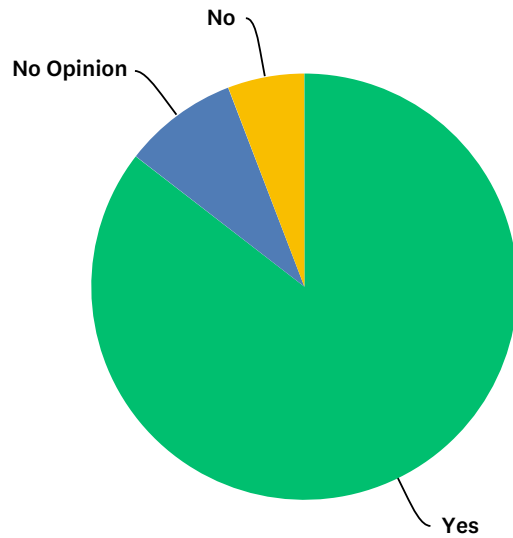
